# From the desk of Gail: Executive Director

#### Hello Everyone,

What a busy month January was! Besides all the snow, we had our annual Agency Review by Calgary & Area Child and Family Services. Karen Thiessen our Licensing Officer visited 15 of our family day homes.

## These are her findings:

#### Providers did not have child information for all children in their homes.

As a result we are now implementing for March 31, 2014 that all Providers must have a fax machine. Each Provider must know how to receive the child information on their fax. The fax must be equipped with paper and ink. NO PROVIDER IS TO ACCEPT CHILDREN IN THEIR HOME UNLESS THEY HAVE ALL THE CHILD INFORMATION RECORDS; INCLUDING THE EMERGENCY PORTABLE RECORD STATING IMMUNIZATIONS (VERSION DATED JANUARY 2014). EVERY BACK UP CHILD YOU ACCEPT INTO YOUR HOME MUST HAVE AN EMERGENCY PORTABLE RECORD COMPLETED BY THE PARENT BEFORE THEY LEAVE.

# Attendance Records

Children's attendance must be recorded when they are dropped off and picked up by the parents or the providers. These records must be current and not pre-signed or signed at a later date.

#### Provider out of ratio, 7 children in her home for 30 minutes.

If you ever find yourself in a situation where you would have 7 children in your home you MUST say to the parent that they cannot drop off their child. YOU CAN NEVER HAVE 7 CHILDREN IN YOUR HOME.

# Playpen not approved for sleeping.

All playpens used for napping MUST state that they are approved for sleeping. Graco Pac N Play states on the playpen mattress it can be used for sleeping.

#### Day Home furnishings were not clean

All day homes' furnishings, toys, equipment and environment must be clean and free from clutters and in good repair.

## Visual Identity not displayed in a prominent place in day home

If your red door sign becomes faded please ask your consultant for a new one; keep your old one posted until you can replace it with the new one

## Programming for January not completed or posted.

Please ensure that your monthly programming is completed and displayed on or before the 1st working day of the month.

#### Personal Care products were accessible to children.

All personal care products must be inaccessible by a u-clamp or a lock. A cabinet over the toilet is not acceptable unless it is locked.

# Valentines Day Activity Paper Hug



## What you need:

- Construction Paper
- Cardboard (old cereal boxes work great!)
- Paint
- Googly Eyes

#### **Directions:**

- 1. Gather your materials. You will need some cardboard or other sturdy paper, paint, construction paper (red, black or any color), googly eyes, scissors and some glue.
- 2. Draw one large heart and 2 smaller hearts on the cardboard.
- 3. Have the children paint the small hearts
- 4. Paint the large heart. Let dry.
- 5. While that is drying, take your red paper and fold it into a fan. Cut two pieces off for the arms.
- 6. Cut a mouth out of the black paper.
- 7. When the paint is dry cut out the hearts.
- 8. Add the glue for the mouth and the eyes.
- 9. Add the eyes and mouth.
- 10. Glue the small hearts onto the ends of the arms for hands.
- 11. Glue the arms to the big heart!

# **Making Connections**

Your home is your day home child's second home. Supporting an interactive connection between the child's home and day home is an important aspect in having a successful day home. Promoting activities and conversations that reflect individual children's lives is beneficial for the children, parents and the provider.

# Here are some fun interactive ideas and activities that you can try in your day home!

- Ask parents to bring their child's favorite CD from home.
- Ask parents to teach you and the day home children songs that they sing at home
- Initiate conversations with parents regarding things the child has done over the weekend (or evening) and talk to the child about these events during the day
- Plan a day home / family event. Christmas party, Day home pancake breakfast, family Easter egg hunt, holidays that you celebrate or a holiday the day home child might celebrate
- As parents to collect recyclables for day home projects
- Ask parents to bring in family photo's
- Make a day home family tree with photo's of have the child draw a picture
- Show and tell
- Invite Grandma, Grandpa or another family member to the day home for an afternoon tea

## Benefits for parents:

- Feel included in their child's day
- Feel more connected, informed, and feel like they have a voice and important role in the day home
- Helps build trust
- Can see their family, culture and beliefs are being reflected

- Better relationships and communication between you and the day home families

# Health Canada Recalls: POOF®-Slinky®/Scientific Explorer Lava-Blasting Volcano Kit and POOF®-Slinky®/Scientific Explorer My First Chemistry Kit

Health Canada's sampling and evaluation program has revealed that the recalled kits contain hazardous chemicals and have been sold in Canada without the required safety warning statements and labels. These labels direct the user to important safety information regarding use of the chemicals provided with the product. In addition, it has been identified that the Lava-Blasting Volcano Kit contains a substance in a quantity which exceeds that allowed under the Canada Consumer Product Safety Act and its Regulations. Inclusion of prohibited quantities of substances and a lack of required labeling can both lead to serious adverse health effects.

## Playtex recalls Pacifier Holders

Health Canada said approximately 150,000 holders distributed in Canada at various retailers. Products affected include the Playtex pacifier holder clips that attaches a pacifier to items like clothing, diaper bags and strollers. The pacifier holders are identified by UPC number 7830005924 and were sold from July 2010 through October 2013 in Canada and the United States. No injuries have been reported. The pacifier holder was sold in green with a monkey figure, pink with a flower and blue with a tow truck. Consumers are told to stop using the pacifier holder and contact Playtex Products Inc. for a refund at (888) 220-2075 or online at www.playtexproducts.com
